5. Reports:

- 5.1 Treasurer's Report: Balance stands at £7800.16.
- 5.2 Paths Working Group: Full minutes from PWG meeting available on request.
 - 5.2.1 Good discussions with Lairds re quarry diversion but completion is expected within months. Exact route and surface still under discussion. Query whether 3m width is necessary. Query screening planting: **A.Christie**
 - 5.2.2 Actively engaged with F.C, Access officer re locked gates on B936 leading to path FN432. Will try and establish landowner for discussion. **A.Christie**
 - 5.2.3 Still trying to establish who owns wooden sign for Coffin Road. A.Christie
 - 5.2.4 Continuing low level maintenance of paths. Thanks to volunteers. Seeking to establish ownership of land around Gaddon Loch for core path FN 432. Request public assistance.

5.3 Speed reduction:

5.3.1 Telraam system recovered and to be deployed in Charlottetown during April.

- 5.3.2 Traffic police completed unmarked speed assessment on B937 and were 'horrified' at speeds. Police have indicated they are pursuing installation of two active speed monitoring signs. One in Edentown and one in Giffordtown. But they may instal mobile unit initially.
